

# Continuing Education (CE) Requirements For PWME

## GRADUATES

---



**A Graduate has:**

1. Completed the Initial-9 Hour class **and**
2. Accumulated at least 10 hours of continuing education (CE)



**Graduates must attend one CE class within every 3-year block**

The 3-year blocks are fixed, based on the year of graduation



Those with sufficient education acquired prior to 2012 were automatically designated graduates as of 12/31/11.
